# **ILASLA AWARDS** CALL FOR NOMINATIONS

# **PUBLIC AWARDS**

ILLINOIS

Each year, the ILASLA recognizes individuals or organizations that have significantly enhanced the Illinois landscape or promoted the profession of landscape architecture in the State of Illinois. These awards are given in an effort to heighten public appreciation of landscape-related issues and to expand public awareness of the landscape architecture profession and the ASLA.

# **Eligibility:**

Nominees must be individuals or organizations that have significantly enhanced the Illinois landscape or promoted the profession of landscape architecture in the State of Illinois. Membership in ILASLA is not required. There is no entry fee required for the Public Awards.

# **Nomination Methods:**

Nominees may be entered for consideration in one of the following ways:

- Members of the ILASLA or ILASLA executive committee may nominate
- Members of allied organizations may nominate
- Any individual or organization may nominate himself or herself

# Awards:

## **Public Recognition**

Recognizes projects, legislation, articles, individuals or organizations that have significantly enhanced the Illinois landscape or promoted the profession of landscape architecture in the State of Illinois. The Public Recognition Award is presented at the discretion of the ILASLA Executive Committee.

## **Community Service**

Recognizes a landscape architect, landscape architecture firm or related agency for volunteer efforts that have contributed significantly to the improvement of communities within the State of Illinois, with particular regard for the enhancement of public landscapes. The Community Service Award is presented at the discretion of the ILASLA Executive Committee.

#### Advocacy

Recognizes: an individual or appointed or elected official who has advanced or promoted the cause of planning in the public arena. Presented at the discretion of the ILASLA Executive Committee and Advocacy Committee. Criteria for recognition includes the following:

- **Support of landscape architecture and landscape architects.** Illustrate how the nominee's work has increased the understanding of the design process. Indicate how the nominee has shown a clear understanding of, and support for, the role of landscape architects in public life.
- **Effectiveness and results.** Describe the extent that the nominee has been effective in formulating and implementing plans and ideas in support of good landscape architecture (both design and planning). Identify the level of influence and effectiveness achieved by the nominee within different segments of the community.

#### Organization / Firm of the Year

Recognizes firms or public agencies that employ landscape architects that has produced distinguished work that continues to influence the professional practice of landscape architecture. Chosen by ILASLA executive committee. Criteria for recognition includes the following:

- **Quality.** Demonstrate consistent quality of the firm's work and its recognition by the general public or those who practice or sponsor landscape architecture, teach landscape architecture, or develop communities. Elements of quality include graphic design, content, evidence of implementation by clients.
- **Influence.** Detail the firm's positive influence on the direction and professional advancement of landscape architecture, for example promoting new technologies, collaboration among other design disciplines, innovations in practice, and advances in the art and science of landscape architecture.
- **Ethical Practice.** Explain how the firm consistently upholds and champions the highest standards of ethics in terms of the public trust and guiding and educating its staff on the importance of ethics.
- **Outreach and Engagement.** Demonstrate the firm's efforts and skills in engaging stakeholders and resolving community conflicts with positive outcomes. Demonstrate responsiveness to the client and the various elements of the community in the design process and willingness to incorporate ideas and suggestions from the community.

#### **Outstanding Student**

Recognizes individual students that have significantly enhanced the Illinois landscape or promoted the profession of landscape architecture in the State of Illinois.

#### **Other Award**

The ILASLA Executive Committee may, at its discretion, recognize individuals or organizations for reasons other than the above. Additionally, the Chapter President (past or present) has at his or her sole discretion the ability to award a person or firm, member or not, Chapter Recognition for exemplary contribution to the art and science of landscape architecture.

## Submission Requirements:

• **Entry form (Online form):** The entry form is a Google Form, and all information <u>must</u> be entered digitally. Please note: The online form should allow you to close out and come back to a partially completed form. However, for best results, please have your entry text in a separate file to avoid any technology issues.

• **Description (PDF)**: The nomination description is an editable PDF and all information must be entered digitally. PDF must be uploaded through the online form.

• **Presentation (PDF)** (IF APPLICABLE, Recommended for Organization / Firm of the Year): with a 15 page maximum limit. PDF must be uploaded through the online form. InDesign and PowerPoint templates downloadable on www.il-asla.org <u>must</u> be used to complete the presentation. Background color and font must not be edited. PDF must be uploaded through the online form. The presentation must include the following:

- Slide 1: Submission Category
- Slide 2: Nominee(s)
- Slides 3-15: Images representing the submission (300dpi). <u>One image per slide</u>, *except* in the instance of "before and after" image sequences wherein two images are allowed per slide. Each slide must include:
  - Submission Category
  - Up to five sentences describing each drawing or photograph

# **Deadline for Submissions:**

The ILASLA Awards Committee must receive all entries no later than **5:00 p.m. on Friday, April 28, 2023**. Entry includes the online form. Late nominations will not be accepted. Award recipients will be notified of the results via email. All submissions become property of the ILASLA and will not be returned.
